Under this evaluation mechanism, many TCM colleges and universities have to give up the characteristic development strategy, step on the road of homogeneous competition, and



begin to develop into multi-disciplinary and comprehensive colleges and universities, losing the original industry characteristics. In order to meet the market demand and improve the overall strength, these colleges and universities may continue to expand the scope of the campus, non-characteristic specialty. In the long run, the homogeneous competition may lead to the loss of the competitiveness of TCM colleges universities, with their characteristics are weakened, and the elements of strengthening base kinetic energy are insufficient, which affects the cultivation of the connotative development kinetic energy in TCM colleges and universities.

3.2 Anxiety for Cultivating New Kinetic Energy, and Separation of Talent Cultivation from Reality

Compared with 211 and 985 colleges and universities, most TCM colleges universities are facing the dilemma of insufficient development funds. In order to meet this challenge, TCM colleges and universities actively cultivate new growth points and explore new development directions. However, in the process of pursuing new growth points and new development directions, some TCM colleges and universities have fallen into aimlessness. They blindly pursue novelty and scale, ignoring their own strength and social needs. This kind of aimlessness leads to the cultivating new kinetic energy separated from reality. In the final analysis, the innovative elements of the connotative development kinetic energy are the cultivation of innovative disciplines. In order to achieve this goal,

colleges and universities need to cultivate interdisciplinary and emerging disciplines based on the multiple elements such as comprehensive school strength, disciplinary system, supporting disciplines and social needs, and combining the development of existing disciplines [5]. For example, a traditional Chinese medicine university plans to open the specialty of pharmaceutical affairs management, which belongs to the category of science. The specialty aims to cultivate highquality basic knowledge of pharmacy, basic knowledge, basic theory and basic skills such as law and management for the development of local economic and social development, traditional Chinese medicine cause and health industry, systematically understand policies and regulations of pharmaceutical management, and can apply the theories and methods of law. administration management to analyze and research the medical social problems such as drug access,

drug quality and drug safety, and for highquality applied and interdisciplinary talents engaged in the supervision and management of all aspects of drug lifecycle management, only on the basis of pharmacy, law and management disciplines can the college have disciplinary support to set pharmaceutical management specialties. If the "cultivating new kinetic energy" is advanced lacking basic disciplinary much. foundations, disregarding actual conditions, and blindly adding new specialties, it will inevitably lead to unqualified talent cultivation, waste of educational resources, and impact the connotative development of colleges and universities.

3.3 The Quality Elements are Insufficient, and the Kinetic Energy Effect Needs to be Improved.

In the "China's Education Modernization

2035" plan issued in 2019, the Chinese government proposed to improve the quality of education, promote education equity, and cultivate builders and successors for the allround development of morality, intelligence, physical education and work. In the higher education of traditional Chinese medicine, improving the quality has always been the goal of all TCM colleges and universities. Although TCM colleges and universities regard quality elements as the core factors of cultivation in the process of connotative development, the quality kinetic energy can not meet the requirements of connotative development, and the actual effect of quality kinetic energy needs to be further improved. Although TCM colleges and universities have realized the importance of quality kinetic energy, it is very difficult to implement it. It is mainly manifested in that the extensional development is characterized by scale expansion and quantity increase, and the shortterm benefits are easier to show and are still regarded as the focus of development, while the cultivation of quality kinetic energy is only superficial. However, this development model has led to problems such as the mismatch between talent supply and demand, declining quality of talent cultivation, and waste of educational resources, thereby affecting the cultivation of connotative development kinetic energy and the improvement of education quality.

The construction plan of "double-first-class" breaks the solidified identity of traditional colleges and universities, and all colleges and universities stand on the same starting line, so that schools with foundation. strength, methods achievements stand on the same starting line to compete [6].

4.2 Improved the Fairness of Striving for First-Class in TCM Colleges and Universities

In China, higher education faces a rather unique environment characterized by limited theoretical research and inadequate policy guidance, resulting in blurred categorization among higher education colleges universities, unclear positioning in teaching, undefined development directions. National development policies have not provided targeted guidance based on the characteristics. disciplinary development, and current status of universities, which is unfair for distinctive TCM colleges and universities and detrimental to the cultivation of diverse talents needed for national development [7]. The "Overall Plan for Promoting the Construction of World-Class Universities and First-Class Disciplines" issued by the China in October 2015 clearly states in its supportive measures: "Overall planning, tiered support" and "Universities shall choose a path for building world-class universities and first-class according to their actual situation." It

encourages and supports different types of universities to combine their own circumstances and choose a development path rationally, promoting differentiated development of disciplines. For TCM colleges and universities, it is imperative to swiftly embark on this fast track of development and steadfastly pursue the path of connotative development [8].

4.3 Stimulated the Enthusiasm of TCM Colleges and Universities to Strive for First-class

The development of "characteristic" is the magic weapon for the schools to survive. Under the guidance of the idea of running a school with characteristics, the construction of first-class colleges and universities emphasizes on the characteristics. For TCM colleges and universities, there are unique advantages in such aspects as prominent discipline characteristics and distinct service orientation. Through reasonable allocation of funds, they shall strive for certain supporting policies on the basis of fair competition and "speed-up pump" start the of rapid development. Promote the enthusiasm and initiative of connotation construction, inject endogenous power and development vitality into the school's planning for development.

5. Exploration on the Cultivation Path of Connotative Development Kinetic Energy in TCM Colleges and Universities

5.1 Maintain Strategic Determination and Stick to the Development Road

Strategic determination refers to the strategic self-confidence, will and perseverance to achieve strategic intention and strategic goal under the complicated situation [9]. The concept of strategic determination is designed to encourage people to have firm conviction and determination in the face of uncertainty, not affected by local and specific events, and to respond calmly to challenges in order to achieve the long-term interests of our country and nation. For the development of TCM colleges and universities, it is essential to maintain and continuously strengthen the determination for connotative development, steadfastly following the path of connotative development.



In 2010, the China adopted and issued the "Outline of China's National Plan for Medium and Long-term Educational Reform and Development (2010-2020)". The outline of the "Promote education plan clearly states: development from purely quantitative expansion to quality improvement, and achieve connotative development." In the past, the extensive development focused on scale expansion, and it is easy to ignore the quality of education. However, the connotative development emphasizes to deepen the educational reform, improve the quality of education, and cultivate high-quality talents with innovative spirit and practical ability, so as to meet the needs of national and social development. Just as the educator Mr. Tao Xingzhi said," Education is to cultivate a new generation, not just to impart knowledge." Therefore, colleges and universities adhere to the connotative development, which is not only in line with the national education development strategy, but also an inevitable choice for inheriting and developing education cause and cultivating excellent talents for allround development."

5.2 In-depth Analysis to Find Gap, Continuous Improvement to Set Goal

On the basis of in-depth scientific analysis, this paper finds out the problems existing in the construction of education and teaching, scientific research innovation, teaching staff and social service in the connotative development of TCM colleges and universities. According to the development goal, there are many improvements in the cultivation of the connotative development kinetic energy of TCM colleges and universities. To clarify the gap to the target, TCM colleges and universities shall improve from the following aspects.

In education and teaching. Although the discipline of TCM is unique, there is still some lag in teaching mode and curriculum setting. We shall innovate the educational teaching mode, optimize the curriculum setting, adjust the curriculum structure, strengthen the basic curriculum, broaden the specialized curriculum, and improve the teachers' teaching ability and professional accomplishment. At the same time, we shall pay attention to the individual development of students, carry out teaching according to their aptitude, train



students to have creative spirit and critical thinking, and adapt to the needs of talent cultivation in the new era.

scientific research and innovation. Compared with other fields, the efficiency of transforming scientific the research achievements of TCM into the industry is low. Therefore, it is necessary to optimize the education system, improve the scientific research literacy, strengthen the construction of teachers and improve the overall scientific research capability. The schools shall build a scientific research platform for teachers and students, provide adequate scientific research resources, strengthen academic exchange and cooperation, formulate incentive policies, and promote the transformation of scientific research achievements. In the construction of teaching staff team, because of historical reasons, the number of teachers of TCM specialty is insufficient and the structure is unreasonable. Colleges and universities shall optimize the mechanism of selection and employment, introduce high-level teachers, strengthen the cultivation of in-service teachers, establish incentive mechanism, improve the remuneration of teachers and stimulate their enthusiasm in that provision of social service. Traditional Chinese medicine colleges and universities can obtain resources by giving full play to their own characteristics, helping the country solve major scientific accelerating research issues and achievement transformation of educational resources in the field of traditional Chinese medicine [10]. Colleges and universities shall strengthen the cooperation between schools and enterprises, deepen the integration of production and education, and improve the transformation rate of scientific research achievements. At the same time, it is necessary to strengthen the communication of TCM culture, improve social influence, let more people understand and recognize the value of TCM, enhance the competitiveness of TCM in the international market, and make contribution to greater global health undertakings.

5.3 Cooperate with Internal and External Forces to Promote Connotative Development

In order to realize the connotative development in TCM colleges and universities,

As the valuable wealth of the university, alumni have rich social resources, network and practical experience. Making full use of alumni resources can promote the popularity of colleges and universities, promote the cooperation of industry, university and research, broaden the employment channels of students, strengthen the cohesion of colleges and universities, and provide strong support for the fund raising and brand image of colleges and universities, so as to promote the connotative development in colleges and universities and improve the overall strength and competitiveness.

6. Conclusion

This paper focuses on the cultivation of connotative development kinetic energy in TCM colleges and universities, analyzes the
